North Central Water Authority sent out letters that they were having a water rate increase. With the water increase and the chemicals increase they council decided to increase the basic water rate by 1.83 to cover the rising increases. The current basic water runs \$25.67 and with the increase it will run \$27.50. Sandy Flores made the motion to increase the Basic water rate and Kyle Kittley seconded. All in Favor.

Changing of the City Council Meetings was discussed, and it was decided to move the monthly meeting to the first Wednesday of each month at 5:30 P.M. Kimberly Eaton made the motion for the change of day and Bob Clark seconded. All in Favor.

TML elections were discussed, and the council agreed to allow Joyce to send in the vote for the city. Bob Clark made this motion and Kimberly Eaton seconded. All in Favor.

Motion to adjourn. Sandy Flores made the motion to Adjourn, and Kyle Kittley seconded. All in Favor.
