It is for the water well. It would work if we put in a separate meter for the water well but this will be discussed at next months meeting.

Christmas Bonus was discussed. Delle said last year Joyce and Hugh received \$350.00 and \$150.00 for Dean. She would like to recommend \$500.00 for Joyce and Hugh. The council wanted to enter into an executive session to discuss the bonus and personnel.

Regular session ended at 6:39 pm and entered into executive session at 6:39.

Executive session ended at 7:20 pm and entered back into regular session.

The council will have a Special meeting on Monday the 6th at 5:30 pm.

It was decided to give Hugh and Joyce a \$400.00 Christmas Bonus on the paycheck issued on the 15th.

Public Works- Raised up 2 manholes to street level, replaced 1 older meter with new meter and a riser, replaced 2 old broken meter cans, mowed sides of the streets, patched holes around town. The shop is up and sheeted in, waiting on doors and insulation. Terry Letz is in the process of getting the heater fixed at the depot. Has been talking to Harn R/O about coming and doing our calibrations and have been trying to get the water tower and tank inspection done. Took one dog to Stamford. While he and Brian are at school next week, they will drop off the Ford in Anson and have the mirror and backup camera fixed while they are gone.

Fire Report- They had a vacant house fire, 2 EMS assists, replaced 2 batteries on Truck 94. Went to the Fall Fest at the school to give rides on the fire trucks for the kids. Hosted Trunk or Treat at the Fire Dept. and handed out candy.
