Terry Letz's quote for wiring the new City Shop was presented to the council. Kimberly Eaton made the motion to have Terry Letz do the wiring and Sandy Flores seconded. Motion passed.

Code Enforcement- Manuel sent word that he could no longer come for our code enforcement because Stamford has him doing more positions. He stated that the city could enforce our ordinances without him, and our Judge could set fines if they don't comply.

Public Works- Hugh gave his report. They fixed a 2 inch leak on 800 block of Amity, cleaned out the city shop and tore it down, mowed sides of the streets and working on the sewer plant, service line leak in alley north of the baseball field, got the Ford back- fuse box was shorted out and had to have a new battery, sprayed mosquitoes, registered for school in Lubbock for him and Brian in November. County will be here before long to blade the streets, he talked to Russell earlier this week. Wrote 4 dog citations and took 2 dogs to Stamford. He said we order 2 batteries for the Fire trucks and ask if the city wanted to pay or have the fire dept. pay. It was discussed paying for one from the city and the other from the fire dept. Sandy Flores made the motion to pay for one and Kim Stulir seconded. All in favor.

Cemetery Report- No report. Jeffery wasn't present.

Fire Dept. Report- Hugh gave the report. They responded to 4 grass fires, order the 2 batteries for truck 94. The dept. will be doing Fire Prevention at the school on the 12^{th} . They will also be doing Trunk or Treat on Tuesday the 31^{st} from 6-8 pm at the Fire Dept.

Sandy made the motion to adjourn, and Kimberly Eaton seconded, All in favor.
